Walsh, United States Bankruptcy Judge, at the United States Bankruptcy Court, 824 Market Street, 6th Floor, Courtroom #2, Wilmington, Delaware 19801.

IF NO OBJECTION OR RESPONSE TO THE E&Y RETENTION APPLICATION IS TIMELY FILED, SERVED AND RECEIVED IN ACCORDANCE WITH THIS NOTICE, THE BANKRUPTCY COURT MAY GRANT THE RELIEF REQUESTED IN THE E&Y RETENTION APPLICATION WITHOUT FURTHER NOTICE OR HEARING.


